Log Book Discussion:

Bob Kratzer received information from WDFW that last year 31 guides reported at least one trip on the Yakima River. That's about what we figured the number was.

WDFW Enforcement has been issuing tickets for not doing logbook entries recently. Most of these are being dismissed by the prosecutors because they are improperly written or legally insufficient. They are issuing tickets without verifying ID even though at times they check the box on the ticket that they did so. They must verify exactly who is operating the boat, they can't just write a ticket to the owner without verifying the ID of the operator. They need to actually walk up and talk to the boat operator and confirm who it is legally. WDFW enforcement is being lazy, unprofessional, and illegal.

Doug: Logbooks are due the 10th of the month following the guiding activity. That's not enough time to ensure everything will actually even get there through the mail with the paper logbook reports. They claim they witness guiding then wait to see if the logbook entry shows up, then issue a ticket. There shouldn't be a rush to get the tickets issued, wait till the 15th or 16th to make sure it didn't go to some branch office or regional headquarters by accident and is on its way via interoffice mail.
