Hatchery Wild Coexist Fundraiser

- Event scheduled for December 6th at Ilani Casino
- Proposal to sponsor a table for \$1,500, including seats for WSGA members
- General agreement on the value of WSGA presence at the event
- Noted affiliation between Hatchery Wild and CCA (Coastal Conservation Association)

North of Falcon Compensation

- Consideration of various compensation models, including per diem and lost fishing day reimbursement
- Plan to revisit and potentially decide on compensation at the November meeting

Sports Show Booth

New Tax Guidance from WA Dept. of Revenue

- Greg Kain received email detailing new tax obligations for guided fishing and hunting services
- Key points:
 - Taxes to be collected based on launch location, not business office location
 - Sales tax due on all equipment used in providing guide services
 - Potential changes to what items are considered taxable (e.g., bait, lures)
- Concerns raised about the administrative burden and financial impact on guides
